



WAIVER AND RELEASE RELATING TO CORONAVIRUS/COVID-19

Consent: By my signature below, I/we consent to the student (students) to participating in any and all activities sponsored by Junior Assembly of North Dallas, a volunteer, non-profit, 501(c)(7) organization, irrespective of what host locations and venues such activities will occur at. I/we understand and acknowledge that Student's participation in such activities sponsored by Junior Assembly of North Dallas may expose Student to contact with one or more persons or objects that have been infected with, and/or exposed to, diseases or viruses, including the virus commonly known as COVID-19. I/we understand that, as a result, Student's participation in school-sponsored activities may expose Student to the risk of exposure to or infection with diseases or viruses such as COVID-19. I/we understand that the potential risks associated with exposure to or infection with diseases or viruses such as COVID-19 are not fully known, but may include significant and serious illness, bodily injury, disfigurement, or temporary or permanent disability. I/we understand that the use of personal protective equipment may not fully protect against or mitigate the risks posed by Student's participation in school-sponsored activities. I/we understand and agree that information regarding the COVID-19 status of Student and/or individuals that live in the same household as Student may be disclosed to others participating in activities sponsored by Junior Assembly of North Dallas, should Junior Assembly of North Dallas—in its sole discretion—deem such disclosure necessary.

Assumption of Risk: **I/we have read and understood the above warning concerning COVID-19.** Nevertheless, having considered the risks, including those outlined in this Waiver and Release, I/we consent to Student's participation in any and all activities sponsored by Junior Assembly of North Dallas. Accordingly, for good and valuable consideration, including without limitation Student's membership in and access to activities sponsored by Junior Assembly of North Dallas, I/WE HEREBY ASSUME ALL RISKS OF STUDENT'S PARTICIPATION IN SUCH ACTIVITIES, INCLUDING WITHOUT LIMITATION, THE RISK THAT STUDENT MAY BE EXPOSED TO OR BECOME INFECTED WITH COVID-19.

Waiver of Liability and Release: **I/WE HEREBY, FOR MYSELF AND MY HEIRS, SUCCESSORS, AND ASSIGNS, AND ALL THOSE CLAIMING BY OR THROUGH ME, WAIVE, RELEASE, AND AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS JUNIOR ASSEMBLY OF NORTH DALLAS AND ITS OFFICERS, BOARD OF DIRECTORS, EMPLOYEES, AGENTS, REPRESENTATIVES, VOLUNTEERS, AND HOST LOCATIONS AND VENUES (COLLECTIVELY "INDEMNITEES") FROM AND AGAINST ANY LIABILITY, LOSS, EXPENSE, OR OTHER DAMAGE, WHETHER KNOWN OR UNKNOWN, FORESEEN OR UNFORESEEN, INCLUDING PERSONAL INJURIES, PROPERTY DAMAGE, DEATH, COSTS OF COURT, AND ATTORNEYS' FEES, ARISING FROM OR IN CONNECTION WITH STUDENT'S PARTICIPATION IN ACTIVITIES SPONSORED BY JUNIOR ASSEMBLY OF NORTH DALLAS, INCLUDING THOSE WHICH ARISE OR ARE ALLEGED TO ARISE FROM THE NEGLIGENCE OF ANY INDEMNITEE.**
